


PRIVACY POLICY

Introductions

Humans Net, Inc. ("Humans" or "We") respect your privacy and are committed to protecting through our compliance with this policy.

This policy describes the types of information we may collect from you or that you may provide when you visit the website <http://humans.net> (our "Website") and use our "humans.net" mobile application (collectively, the "Service") and our practices for collecting, using, maintaining, protecting, and disclosing that information.

For the purposes of EU data protection laws ("Data Protection Law"), Humans.net is data controller [i.e., the company who is responsible for, and controls the processing of, your personal data].

This policy applies to information we collect:

- On the Service;
- In telephone calls, email, text, and other electronic messages between you and Humans;
- From offline activities and communications.

It does not apply to information collected by:

Information We Collect from You and Purpose of Collection

We collect several types of information from and about users of our Service, including information:

- About your internet connection, the equipment you use to access our Service and usage details.

We collect this information:

- Directly from you when you provide it to us;
- Automatically as you navigate through the Service. Information collected automatically may include usage details, IP addresses, and information collected through cookies, web beacons, and other tracking technologies;
- From third parties, for example, our business partners, including, without limitation, Assembly, if such information is provided to us.

Information You Provide to Us:

Information We Collect Through Automatic Data Collection Technologies
